This agreement does not provide for the control of termites, fungus, beetles, or any other pests not indicated herein. This plan does not guarantee, and Freedom Pest Control LLC does not represent, that covered insects will not return to the Property.
- 2. PURCHASER'S RESPONSIBILITY. Your cooperation is important to ensure the most effective results from Freedom Pest Control LLC's service. Whenever conditions conducive to the breeding and harborage of pests are reported in writing by Freedom Pest Control LLC, and not corrected by you, Freedom Pest Control LLC cannot assure satisfactory service. If the conditions noted by Freedom Pest Control LLC are not corrected as required, all guarantees in this agreement shall automatically terminate and be canceled.
